 - i. Nothing appears to be happening w/the Mission College Satellite Campus. She has a call in to college Pres Perez, but has not heard back. Is a bit concerned because a tenant at the Commerce Town Center says the lease has not yet been signed

- ii. At the LANCC meeting on Sat, they passed a Motion to send to Sacramento and to City Council to make them spend the money they were supposed to spend for rehab, transitional housing, etc for those being let out early per Prop 47/109
 - Suggested each NC send a letter individually though LANCC should speak for all 96 NCs

d. Luke Vella

- i. Re the transient population the past three to four days it has tripled. Has been the victim four times in the last month. The police are not doing anything. It took them 45 minutes to respond to a home invasion call on Tujunga Bl.
- ii. The police do not return calls, the homeless are not getting prosecuted for crimes they commit. Right now there are 10 shopping carts on Scoville/Foothill. There are 2-3 homeless guys there
 - 1. These guys go up and down the BI they are aggressive they are criminals they constitute about 5% of the population they are ruining the community they are in front of restaurants
 - 2. They are scaring people something has to be done, there has to be a change there are a lot of people that feel the way I do they are fed up with the crime. Lock your cars, lock your houses
 - They are moving into vacant houses, manufacturing fake rental agreements requiring owners to go through formal eviction processes – they steal whatever they can from garages
 - 4. The police force admits crime stats due to transients have doubled or even tripled transients know they can get away with this stuff
 - 5. One night a kid stole a generator from me the police did not want to go through his bags, he ran away, came back to get his bags and left
