- III. Approval of Minutes

- IV. Committee Member Up-Dates
 - a. Cindy Cleghorn
 - i. We need to fill committee vacancies. Arsen Karamians has resigned for health reasons.
 - The LUC discussed the possibility of dropping William Malouf as an alternate. He has indicated interest in helping when available. Per Cindy C. he would agree to attend if needed to establish a quorum
 - Availability to establish a quorum is the primary function of an Alternate, as such the LUC consented to retain William M. The Committee still has a third alternate position vacant
 - 3. The LUC discussed By-Laws definition of LUC, its membership and potential people to reach out to for filling Committee vacancies.

VI. New STNC Transportation Committee

- a. The STNC has voted to establish a Transportation Committee. It is important for the LUC to be aware of it and to have a liaison serving on or attending Committee meetings such that we do not move in contradictory directions or duplicate efforts
 - The LUC generally deals with transportation issues as they relate to specific projects whereas the Transportation Committee would work with general traffic issues eg speeding on Foothill Bl.
 - 1. Input from LUC would be important when analyzing how a specific development may impact Sunland-Tujunga traffic patterns/issues in general.
 - ii. Discussed issues with the Transportation Committee having stepped outside of/failing to meet purpose as defined by the board of STNC and that it has not held its first meeting to invite participants.

VII. Great Streets Committee
