Every person wishing to address the Board must dial (669) 444-9171, and enter **892 0652 4158** and then press # to join the meeting. When prompted by the presiding officer, to provide public input at the Neighborhood Council meeting the public will be requested to dial *9 or use the Raise Hand option, to address the Board on any agenda item before the Board takes an action on an item. Comments from the public on agenda items will be heard only when the respective item is being considered.

Comments from the public on other matters not appearing on the agenda that are within the Board's jurisdiction will be heard during the General Public Comment period. Please note that under the Brown Act, the Board is prevented from acting on a matter that you bring to its attention during the General Public Comment period; however, the issue raised by a member of the public may become the subject of a future Board meeting. Public comment is limited to **TWO** minutes per speaker, unless adjusted by the presiding officer of the Board.

SB 411 Updates:

In the event of a disruption that prevents the eligible legislative body from broadcasting the meeting to members of the public using the call-in option or internet-based service option, or in the event of a disruption within the eligible legislative body's control that prevents members of the public from offering public comments using the call-in option or internet-based service option, the eligible legislative body shall take no further action on items appearing on the meeting agenda until public access to the meeting via the call-in option or internet-based service option is restored. Actions taken on agenda items during a disruption that prevents the eligible legislative body from broadcasting the meeting may be challenged pursuant to Section 54960.1.

(C) The eligible legislative body shall not require public comments to be submitted in advance of the meeting and shall provide an opportunity for the public to address the legislative body and offer comments in real time.

(D) Notwithstanding Section 54953.3, an individual desiring to provide public comment through the use of an internet website, or other online platform, not under the control of the eligible legislative body, that requires registration to log in to a teleconference may be required to register as required by the third-party internet website or online platform to participate.

(E) (i) An eligible legislative body that provides a timed public comment period for each agenda item shall not close the public comment period for the agenda item, or the opportunity to register, pursuant to subparagraph (D), to provide public comment until that timed public comment period has elapsed.

(ii) An eligible legislative body that does not provide a timed public comment period, but takes public comment separately on each agenda item, shall allow a reasonable amount of time per agenda item to allow public members the opportunity to provide public comment, including time for members of the public to register pursuant to subparagraph (D), or otherwise be recognized for the purpose of providing public comment.

(iii) An eligible legislative body that provides a timed general public comment period that does not correspond to a specific agenda item shall not close the public comment period or the opportunity to register, pursuant to subparagraph (D), until the timed general public comment period has elapsed.

1. Call to Order, Welcome - Lydia Grant, President, 7:00pm

4. Discussion/Q&A with LAPD, Elected Officials/Representatives, DONE, NC Budget Advocates, City Departments (2 min per Representative including Q&A)
 - a. LAPD Officer Godoy reported improved crime stats. Jon questioned LAPD support for college campuses (demonstrations) and Officer Godoy said that some officers did provide

support.

- b. LAPD Officer Alverado reported crime stats and reminded people to not leave items visible in cars and to make sure cars are locked. Susan Denning asked about the homeless people who have relocated from the Golf Course to various areas in town. Mark commented that it is best to put things in the trunk before you park your car so people cannot see what you are putting there. Cindy questioned local graffiti and discussed forms for no-trespassing that are available on stnc.org website.. Lydia commented that we should be pro-active in getting the forms out to the community. Pat Kramer, Chairperson of the Safe Traffic and Transportation Committee, commented that there will be a Traffic and Safety Town Hall tentatively planned for June 15th, Saturday, 9:30-12pm.
- c. Jim Roy, District Representative for CA State Senator Caroline Menjivar, said each Senator has up to 20 bills and deadlines are nearing; the Senator is working on 2 major projects. In the ST area events that are coming up are June 1, the ST Foothill Pride at Sunland Park, and also the SF Valley Pride on June 29th. Further, the Senator plans to join the 4th of July ST parade. Lydia commented that the Senator is also invited to STNC National Night Out event August 6th at Little Landers park and the Movie in the Park event on June 22nd (Saturday), at Sunland Park.
- d. Declan Floyd, Senator Portantino's Office, discussed current bills in the Senator's Office, one allows students allowed to carry NARCAN and schools have fentanyl test strips available. Updated budget projections are in process; budget cuts are expected. Cheryl asked about status of a bill that taxes guns; Declan said that it has changed more to focus on unregistered guns and he will send the updated language to Cheryl (SB 1160). Jon asked if measures can be taken in view of so many people leaving California; Declan pointed to a bill (SB 1102) which encourages small business growth. Lydia asked about bills that impact coastal zones and hoped that Senator Portantino would object to these bills. Lydia noted that there is a 50 unit apartment building in planning that blocks ocean views. Lydia also noted that these units do not address low income/affordable units. Declan noted that Senator Portantino voted against SB50 and SB10 but the coastal bills from Weiner have not come up yet for review. Jim Roy asked Lydia for a list of the bills STNC objects to in order to bring them to Senator Portantino's attention. Lydia said that the State is now suing cities that do not implement their mandated developments.
- e. Diana Oganessian, L.A. County Supervisor Barger's Office, commented about a bill passed to address small businesses impacted by Covid and the recent (writer's) strike, noted that the budget is decreased from last year and said that the LA County Fair is going on in Pomona at this time.
- f. Michelle Vergara, Representative from the Mayor's Office of Public Engagement. Community Engagement team has been growing. Budgets now being discussed and the final budget will be voted on later this month; this is a transparent process and people are welcomed to get involved. The Office is accepting interns at this time. A Community safety survey is circulating for people to express their opinions. People can sign up for current event information if interested. Susan Denning asked for contact information; Michelle said she is the Deputy Director at the office of Community Engagement and her contact info is michelle.vergara@lacity.org. Cindy expressed frustration at STNC not being listened to in too many cases. Jon commented that it seems that the purposeful ignoring

NCs only serves to tell us that we are not important and we will not be listened to. Lydia commented that the Mayor currently does not have a good image with the NCs because the DONE General Manager position assignment was pushed through without any NC involvement, a violation of the City Charter; no one in the NC was notified. Michelle offered to talk to Lydia off-line. Carol agreed with Lydia's comments and frustration about the appointment and said that people from the NCs who had expressed interest in the position were not even notified.

- g. Ricardo Flores, Tujunga Representative from Councilwoman Monica Rodriguez Office. discussed upcoming events. Lydia commented that the Emergency Preparedness event should include the LAPD noting that the school evacuations in the past were very bad and LAPD needs to be involved. Ricardo noted improvements in the area that are now in place. Susan Denning commented about the continuing need for traffic signals and timing. Pat Kramer thanked Ricardo for support with tree watering events. Cindy asked if Councilwoman Rodriguez is aware of the 9604 Hillhaven issues. Pat also asked about the possibility of using the North Valley City Hall in the future. Carol questioned the traffic light and timing at Apperson and Foothill. Lydia commented about homeless behind Auto Zone and also about the signal at Valmont (near Auto Zone) which has timing issues.
- h. Atziri Camarena, Empower LA Civic Leadership and covering for Raul Preciado who is on paternity leave, discussed the budget meeting June 15th at City Hall, the Code of Conduct update (due June 3), offered to help with community events and trainings that are in process at this time. KT questioned why the new Code of Conduct is not on her Cornerstone training list; Lydia reminded people she could help if needed. Cindy asked about the Land Use training to ensure LU Committee members are trained.

Give the block #, you might have to give an exact address, cross street and type, and color, maybe even the lic #. For big trucks only have to give the block#, cross street and color.

Also ask how you can get a regular car to monitor the block.

Many times there are calls waiting, as many as 10, then hang up and try later, for that many it could be 1hr. but if you are working on your computer maybe ok to be on hold. 5 calls can be around 10-20 minutes sometimes.

Example: called in a truck for the first time they gave an option of a call back. This is something new.
