CITY OF LOS ANGELES CALIFORNIA Sunland Tujunga Neighborhood Council Special General Board Meeting Minutes

October 8, 2025, 7pm

This meeting is being held by the Sunland-Tujunga Neighborhood Council using teleconferencing pursuant to Government Code Section 54953.8(a)(2)(B).



1. Welcoming remarks:

- a. **Call to order & Flag salute** Lydia Grant at 7:02pm, with Leny Freeman leading the Pledge of Allegiance
- b. Board Retreat #binders
- c. Emergency Preparedness Committee first meeting. Lydia gave a brief update; the Board is still in the process of organizing at this time.
- Discussion/Possible action to appoint Education Representative, no applications received per Cindy.
- Discussion/Possible action to appoint Region 2 Representative, no applications received per Cindy.
- 4. Discussion / Possible action to **appoint Region 4 Representative**, no applications received per Cindv.
- 5. Discussion/Q&A with LAPD, LAFD, Elected Officials/Representatives, DONE, NC Budget Advocates, City Departments
 - a. Officer Coloca, LAPD, gave a status on crimes in her (Tujunga) area which are in general down. Officer Coloca cautioned about squatters and solicited help in identifying vacant properties, noting that evictions when squatters are established can take months. Coloca asked for help in identifying illegal vehicles (e.g. RVs), commented on the successful recent meeting at Joselito's (Tacos with a Cop) which focused on vacant homes and how ownership of homes can be illegally accomplished, and commented on local gangs and graffiti. Barry identified an area where there is graffiti at this time.
 - b. **Officer Godoy, LAPD,** gave a status on crimes in his (Sunland) area which are also generally down. Godoy commented on an encampment (Range Rover) in Sunland Park and a stabbing that took place. Lydia, Mark and Jon commented. Godoy suggested that grafetti reports be input (on-line) to remove graffiti expeditiously.
 - c. **Battalion Chief Lambert, LAFD Battalion 12**, suggested signing up for emergency alerts from the City, particularly with 'fire season' coming up. Comments and questions came

- from Jon, Cindy, Cheryl and Lydia. Lambert said that water supply to the fire hydrants are checked annually.
- d. Alex Avenesyan, Assemblymember Schultz Office, discussed current bills in process and said that Assemblymember Schultz planned to be at the next STNC General Board meeting. Lydia asked that Avensyan recommend to Schultz not support SB79. Mark noted it should be vetoed and Lydia agreed.

- 8. **Defensible Space Regulations** / Zone 0 / Ember-Resistant / High Fire Severity Zones / Governor Newsom Executive Order N-18-25 Motion to submit CIS to CF 10-2468-S2 at City Council 10-7-25.
 - Lydia noted that bill in process states that everything within 5 ft of the home has to be removed entirely; this bill is being pushed through with minimal community input. Lydia noted that STNC is working to get a reconsideration of the high fire zone map which currently excludes portions of the area (Foothill Blvd) although the excluded area is surrounded by a high fire zone designation. (Ember-Resistant Zone, extends 0-5 feet from a home and requires the most stringent fuel reduction to prevent ember ignition. This zone requires clearing all dead vegetation, flammable materials, and combustible landscaping like wood mulch or bark to prevent fire spread to the structure.) This is an Executive order from Newsom.

- 13. Discussion/Action: **SB79 Update** City voted to oppose Community Impact Statement & Charter Reform Discussion/Possible Action: CF-2025-1152 Neighborhood Council Applicants / Registered Sex Offender Status / Disclosure Requirement / Registry Exclusion
 - SB79. Lydia gave an update of SB70 with comments from Melissa.
 - CF-2025-1152. Lydia gave a description of the bill. Lydia said there was an issue with Studio City NC where she attended a meeting. A community member had researched a potential NC member and found this person had been a school police officer and had been jailed for sexually assaulting students. The Board didn't want to ask directly if the person if they were a sex offender and asked if had previously been in law enforcement - and he said no. They approved him and when they found out, they released him from the Board with the City Attorney getting involved. Lydia felt that we needed to have a position on this including whether they needed to disclose information and if NCs should have to accept them. Comments were made by Jon, Barry, Cindy, Karen, Melissa, Armen and Cheryl that included a caution that this could have impact on other crimes, the difficulty NCs would have to oversee criminal history, the ease of getting the information from websites that investigate criminal histories with websites that specifically identify registered sex offenders with no charge, the position the NC would be in if they accepted a convicted sex offender that would be interacting with children during NC activities, whether NCs could discriminate, what responsibilities and challenges NCs had for investigating potential members, that sex offenses are not like other crimes, and sex offenders are not likely to be rehabilitated even with time served. Rodriguez position is to support keeping registered sex offenders off NC Boards. Lydia concluded that the City has a responsibility to protect people and that further discussions and taking a position could happen at future meetings.

The next LUC is the 10th November. Melissa asked about funding for flyers, etc. regarding Outreach for the Tower which can be approved per Cindy.
- Lydia said that the Emergency Preparedness Committee is trying to get a date and time to meet.

 - Armen inquired about getting STNC shirts which Lydia said are now in storage and the
 next time we went to storage we could get them and put in Cindy's store for people to
 pick up. now in storage. Melissa, per Cindy, can add more shirts in her order if supplies
 are down.
 - Victoria asked if the City budget advocates position have been filled. Lydia said with her
 now being voted in as a member, she could just go to the meetings. Cindy reminded
 that there is a meeting in the near future.
